## **VOLUME I: HOGGESTHORPE & BURGH**

**RAGEMAR**, Lord of Welle, Claxby, Withern, etc. in the County of Lincoln; recorded in the *Doomsday Book* as holding his lands in 1086 by knight service from Gilbert de Gant I, Lord of Folkingham and Bridlington; married and had with other issue,

**WALTER FITZ RAGEMAR**, Lord of Welle, Claxby, Withern, etc.; living *circa* 1115; married and had issue,

William Fitz Walter, Lord of Welle; living *circa* 1166 and after 1184; married Rohese, daughter of Walter de Gant, Lord of Folkingham and Bridlington by his wife, Maud of Brittany, Lady of Swaledale, and sister of Gilbert de Gant II, Earl of Lincoln; *from William and Rohese descend the de Welles family, summoned to Parliament as Barons from 1299, attainted 1474, created Viscount Welles in 1487 and extinct in 1498.*

**HUMPHREY FITZ WALTER,** married Alice, daughter of Robert de Lekeburne, "Keeper of the King's Forests in the County of Leicester" and founder of Lekeburne Priory *circa* 1150, and Matilda, his wife; Alice was left the manor of Saltfleetby by her father and this she held of the King by fee farm rent; Humphrey and Alice had issue along with three daughters,

**WALTER DE CRACROFT**, Lord of the Manor of Cracroft, in the parish of Hoggesthorpe, Lincs.; described in 1202 as being son and heir of Alice "la Connetable" but as having "wasted his inheritance"; in 1248 he is mentioned in a Patent Roll as being an enemy of the King¹; he left issue, an only recorded child,

**STEPHEN DE CRACROFT**, Lord of the Manor of Cracroft, did homage for 48 acres of land in "Hogestorp" to William, Abbot of Bardney, on 12 November 1256<sup>2</sup>; married and had issue,

**WILLIAM DE CRACROFT**, Lord of the Manor of Cracroft, mentioned in Close Roll 2 October 1284<sup>3</sup>; married and had issue,

- 2. John de Cracroft, married Agnes ....., and died 1322/23 without issue.

**ROBERT DE CRACROFT**, Lord of the Manor of Cracroft, sole heir of his brother 1322/23; married 1316/17, Alice de Gunby, daughter of Robert de Gunby; held 6 acres of land by knight service of the heir of Adam de Welle; in 1345 he obtained a licence to have the Mass celebrated in the oratory "infra mansum suum de Cracroft in parochia de Hogsthorpe"; died 2 August 1351/52 (IPM 2 October 1359<sup>4</sup>) leaving issue, an only recorded child,

**JOHN DE CRACROFT**, Lord of the Manor of Cracroft, baptised at Hoggesthorpe 13 March 1335/36; aged 24 on 13 March 1359/60 when he proved his age; mentioned in Close Roll 1361/62<sup>5</sup> and living 1393/94; married Katherine de Westmeades, daughter of Robert de Westmeades, of Skegness, Lincs., and sister and heir of Walter de Westmeades in 1391/92; they had issue.

**ROBERT CRACROFT**, Lord of the Manor of Cracroft, living 1424/25, 1425/26 and 1433/34; married Alice de Rathby, daughter and heiress of William de Rathby, of Horsington, Lincs.; died leaving issue,

**JOHN CRACROFT**, Lord of the Manor of Cracroft; married Margaret Caleflete, sister and heiress of Richard Caleflete, of Burgh-le-Marsh, Lincs.; will dated 8 February 1489/90 and proved at Lincoln 9 April 1490; (to be) buried at Hoggesthorpe, Lincs., leaving issue,

1. William Cracroft, Lord of the Manor of Cracroft; married before 1484 Margaret Topcliffe, daughter of William Topcliffe; died on the Wednesday after the Feast of St Hugh, 1509; IPM taken at Alford, Lincs., on 22 April 1510 having had issue,

- 1a. Henry Cracroft, Lord of the Manor of Cracroft, of full age at his father's death; died on 26 July 1517; IPM at Louth, in November 1517, showed him as holding land in Ingoldmells, Winthorpe, Welton, Theddlethorpe, Stickney and Horsington as well as the manor of Cracroft in Hoggesthorpe.
- 2a. Leonard Cracroft, Lord of the Manor of Cracroft, heir of his brother and aged 23 and more at his death; married Grace Bullen, daughter of Thomas Bullen, of Stickford, Lincs.; died on 3 March 1555/56 and buried in Hoggesthorpe, Lincs.; will dated 18 November 1553 and proved PCC on 1 February 1556/57; IPM at Sleaford on 5 October 1556, having had issue,
  - 1b. Richard Cracroft, Lord of the Manor of Cracroft, aged 40 and more at his father's death; also of Boston and Claxby; recorded his pedigree in the Visitation of Lincolnshire 1564; in the same year he was appointed a Commissioner of the Peace and of Sewers for Lincolnshire; married Margaret Bohun, daughter of John Bohun, of North Willingham, Lincs.; died at Boston, Lincs., on 9 July 1567; IPM at Horsington on 29 April 1568, having had issue,
    - Leonard Cracroft, Lord of the Manor of Cracroft, aged 26 and more at his father's death; a legatee of his nephew Sir John Bolle in 1606; married before 1563 Anne Bolle, daughter of Richard Bolle, of Haugh, Lincs. (buried at Hoggesthorpe, Lincs., on 6 January 1578/79); buried at Louth, Lincs., on 30 September 1615, leaving issue an only child,
      - Richard Cracroft, Lord of the Manor of Cracroft. 1d. baptised at Hoggesthorpe, Lincs., on 15 December 1578; a legatee of his cousin Sir John Bolle in 1606: described as "of Cottenham, co. Camb." in the Visitation of Cambridgeshire 1 October 1618/19 and said to be aged 60 in the Visitation of Lincolnshire 1634; married in Cottenham, Cambs., in 1608, Elizabeth Bendish, daughter of Thomas Bendish, of Bowes Hall, Bumpstead, Essex, and sister of Sir Thomas Bendish, 1st Bart. (and widow of John Pepys, of Cottenham, Cambs.; she was buried there 1642). The Manor of Cracroft was in the possession of Sir Ralph Maddison, of Fonaby, in 1656, who devised it to his son Humphrey Maddison and

grandson Ralph Maddison; it was sold out of this family before 1756.

**RICHARD CRACROFT**, of Ingoldmells<sup>7</sup>, Lincs.; had lands in Partney, etc. by his father's will, which he proved 9 April 1490; married before 1494 Elizabeth .....<sup>8</sup> (died after 1516); died on 24 September 1516; IPM at New Sleaford in November 1516, having had issue,

- 1. John Cracroft, of Ingoldmells, Lincs.; aged 16 and more at his father's death; married Jane Claymond, daughter of Adlard Claymond, of Frampton, Lincs. (proved her husband's will; her will was dated 25 January 1557/58 and proved 15 March 1557/58; after her husband's death she married 2ndly Lawrence Palmer, of Burgh-le-Marsh, Lincs.); died on 14 May 1537; will dated 10 May 1537 and proved PCC 15 November 1538; IPM taken 13 October 1537; from John and Jane descend the Cracrofts (later Cracroft-Amcotts) of Hackthorn, the Cracrofts of Leicester, the Cracrofts of Worcester and the Cracroft-Rice's of Boston, and, through the Nelthorpe family, the Dukes of St Alban's, Northumberland and Buccleuch & Queensbury, and many other peerage families for whom see Volume II.

**ROBERT CRACROFT**, of Burgh-le-Marsh, Lincs.; baptised there on 8 May 1544; married Protasia Quadring (baptised in Burgh-le-Marsh, Lincs., on 21 November 1575), daughter of Thomas Quadring, of Irby, Lincs., and heiress of her mother Margaret Dymoke, daughter of Thomas Dymoke, of Friskney and North Carlton, Lincs.; buried in Burgh-le-Marsh, Lincs., on 21 November 1575; will dated 19 November 1575 and proved at Lincoln on 30 November 1575<sup>10</sup>; IPM taken in 1575/76, having had issue,

**THOMAS CRACROFT**, of Burgh-le-Marsh, Fulnetby and Friskney, baptised in Burgh-le-Marsh, Lincs., on 23 October 1569; married Anne Johnson, daughter of George Johnson, of Thwaite and Wainfleet, Lincs. (proved her husband's will 13 March 1617); by her will dated 23 May 1615, Anne Armine (who died without issue 18 August 1616), the first cousin of his mother, being daughter and heiress of William Dymoke of Friskney and widow of both Charles Bolle of Haugh and Bartholomew Armine of Rodby, devised all her estates to Thomas Cracroft; died on 10 February 1617, will dated on 22 August 1614 and codicil dated on 24 January 1617, proved PCC on 13 March 1617; IPM in 1618, leaving issue,

**GEORGE CRACROFT**, of Burgh-le-Marsh and Fulletby, baptised in Burgh-le-Marsh, Lincs., on, 2 February 1597, son and heir in 1634 Lincolnshire Visitation; admitted as pensioner at Sidney College, Cambridge, on 24 September 1616 and matriculated in same year; married Elizabeth Bolle, daughter of Sir John Bolle, of Haugh, Lincs. (sole legatee of her husband's will; buried at Louth, Lincs., on 9 April 1669); died on 14 October 1637 and buried in Alford the same day; nuncupative will made on 1 October 1637 and proved PCC on 28 November 1637; IPM in 1639 showed him as possessing at the time of his death the manor of Friskney, 146 acres of land in Burgh-le-Marsh, Lincs., 200 acres of land in Bratoft and Gunby and 140 acres of land in Leake; he left issue,

- 4. Edward Cracroft, of Louth, Lincs., baptised in Alford on 6 September 1632; married Elizabeth ..... (living 1686) and was buried in Louth on 30 April 1674, leaving issue,

- Hannah Cracroft, married 1stly, Latimer Crosse, Steward of the lands of Magdalen College, Oxford; and 2ndly, Samuel Nichols MA, Fellow of Magdalen; living 1653.
- 8. Catherine Cracroft, baptised in Fulletby, Lincs., on 2 January 1628; married on 3 January 1654, William Fitzwilliam of Withern; will dated 24 July 1686, then of Louth, Lincs., widow.
- 9. Martha Cracroft, baptised in Burgh-le-Marsh, Lincs., on 27 September 1624; married about 1653 Charles Saunderson; will dated 31 January 1703 and proved 9 May 1704.
- 10. Bridget Cracroft, married at St. Martin's-in-the-Fields, Middlesex, 13 February 1672 Charles Radley, Gentleman Usher to King James II; died 20 November 1679 and buried in Westminster Abbey.

CHARLES CRACROFT, of Louth, baptised at Fulletby, Lincs., on 26 January 1620, aged "12 or 13" in the 1634 Lincolnshire Visitation, aged 17 years, 8 months and 4 days at his father's death; Warden of Louth 1675 and 1684; a legatee of his brother Thomas; married 1stly at Alford, Lincs., on 11 December 1645, Jane Skegness, daughter of Christopher Skegness, of Alford, Lincs. (baptised there on 11 December 1626; buried in Louth, Lincs., on 17 March 1660), and had issue,

- 1. Elizabeth Cracroft, baptised in Alford, Lincs., on 24 September 1646; married 1stly on 22 January 1672, John Ellerker, of Risby, Yorks.; 2ndly (marriage settlement dated on 8 October 1685) William Gee, of Bishop Burton, Yorks.; buried there on 1 December 1726.
- 2. Anne Cracroft, baptised in Burgh-le-Marsh, Lincs., on 17 September 1647 and buried in Louth, Lincs., on 23 February 1683.

He married 2ndly Margaret Barker, daughter of Dr Hugh Barker, of Newbury, Berks. and Great Horbling, Bucks. and widow of Rev Francis Castillion, Vicar of Louth (she died in Louth, aged 75, on 26 March 1712 and was buried there on 29 March 1712); he was buried in Louth on 21 September 1701, leaving further issue.

No 20. At Lincoln on the morrow of St Martin, 41 Henry III (12 November 1256)

Between William abbot of Bardeney, plaintiff, and Stephen de Cracroft, tenant, of 48 acres of land in Hogestorp.

Recognition of the grand assize. Stephen has acknowledged the land to be the right of the abbot and his church. And for this the abbot has granted the land to Stephen: to hold to him and his heirs of the abbot and his successors and his church for ever; rendering therefore yearly 4/- for all service. (Warranty) And, moreover, Stephen has given to the abbot 4 marks of silver. And be it known that Stephen has done homage to the abbot in the same court for the tenement.

#### 3 Calendar of Close Rolls - 12 Edward I (1284)

William de Cracroft acknowledges that he owes to Henry de Blontesden, chaplain, £8 17s 4d; to be levied, in default of payment, of his lands and chattels in co. Lincoln.

The said William acknowledges that he owes to Adam de Clare, clerk, 40s; to be levied, in default of payment, of his lands and chattels in co. Lincoln.

#### 4 Calendar of Inquisitiones Post Mortem -32 Edward III

No 479. Robert de Cracroft

Writ to the escheator in co. Lincoln to enquire as to the land and heir of Robert de Cracroft, who held of the heir of Adam de Welle, a minor in the king's wardship. (Dated) 2 October 32 Edward III (1359).

LINCOLN. Ing. taken at Lincoln on Friday in Easter Week 32 Edward III.

Hoggesthorp. 6a. pasture held of the heir of Adam de Welle by knight's service, who held of the fee of Gilbert de Gaunt by knight's service, and the heirs of Gilbert held of the king in chief by knight's service. Since the death of the said Robert the king has been in possession of the premises and the issues have been received by the escheator from year to year, who let the premises to the best advantage.

He died on 2 August 24 Edward III. John, his son, aged 24 years and more, is his heir.

Peter de Beseby, aged 48 years and more, says that the said John was 24 years old on 13 March Edward III, for he was born in Hoggesthorp and baptized in the church there on 13 March 9 Edward III; and this he knows because John de Beseby, his father, was godfather and caused this to be written in the missal of the church of Hoggesthorp.

Robert de Alford, aged 33 years and more, agrees and says that on Maundy Thursday (*in cena Domini*) after the birth of the said John, John de Alford, chaplain, Robert's brother, celebrated his first mass at Alford, as it is written (*inbreviatur*) in a book (*portiforio*) bequeathed to him by the said John.

Philip de Thoresthorp, aged 46 years and more, and Richard de Billesby, aged 36 years and more, agree and say that at Ascensiontide (*ad festum Ascensionis*) after the birth of the said John the said Philip and Eudo de Billesby, father of the said Richard, went on Pilgrimage to Canterbury in the company of Robert de Cracroft, father of the aforesaid John, to St Thomas, in fulfillment of a vow on account of danger in coming from assizes at Lincoln in thunder and lightning, from which they were in fear of death.

William Ward of Thurlby, aged 58 years and more, agrees and says that his son William was born at Thurlby and baptized in the church there at the feast of Sts Philip and James next after the birth of the said John.

Thomas de Tharlesthorp, aged 37 years and more, and Robert Alisonson of Trusthorp, aged 52 years and more, agree and say that at the feast of St Hilary before the birth of the said John the belfry of Hotoft fell.

Thomas Sarjant of Alford, aged 34 years and more, agrees and says that on Wednesday after the Invention of the Holy Cross following the birth of the said John died Alice, mother of the said Thomas, whose death is written in the Kalendar of the Black Antiphoner there.

Philip Clerc of Hoggesthorp, aged 60 years and more, John son of William of the same, aged 42 years and more, and John Serjant of Malteby, aged 40 years and more, agree and say that about the feast of St Peter-in-Chains after the birth of the said John there was a great indundation of sea-water, which burst out and broke the sea-walls (*fossata maritima*) at Malberthorp and along the coast near and drowned the crops and sheep of divers men of the country round and lasted for two days and more.

Richard de Dalby, aged 31 years and more, agrees and says that Cecily his sister was professed a nun at Greenfield (Priory) on the Sunday after St John-at-the-Latin-Gate after the birth of the said John.

To Walter de Kelby, escheator in Lincolnshire. Order not to intermeddle further with 6 acres of pasture in Hoggestorp, taken into the king's hands by reason of the death of Robert de Cracroft,

and of the nonage of the heir of Adam de Welle, tenant in chief; as it was found by the inquisition taken by the escheator, that Robert at his death held that pasture as his demesne as of fee of the said heir by knight service, that he died on 2 August in the 24th year of the reign, that answer has been made for the issues thereof by the escheator for the time being, and that John son of Robert is the next heir and of full age; and on 27 August in the 29th year of the reign John son and heir of Adam proved his age, and the king respited his homage for the lands which his father held in chief, and ordered livery to be given to him.

"I wyll that Pollen house be let for the space of 20 years and owte of the same I wyll there be taken yerely during the foresaide yeres 13s 4d, which I wyll be distributed among the poore". To my son John Cartar's children 40s apiece. My house on Mosegate. "I wyll that Thomas Cracroft my sonne gyve house roome in the house which I dwell in, that ys to say in the kytchin, to some poore woman to praye for my soul and all my frendes' soules". I make my son Thomas, exr. To Frances Cracroft my son's daughter 40s. To Agnes Cracroft my wife's best gowne.
